In the opinion of Crowe Horwath LLP, the financial statements present fairly, in all material respects, the respective financial position of the governmental activities, each major fund, and the aggregate remaining fund information of the El Dorado Union High School District as of June 30, 2019, and the respective changes in financial position for the year end in accordance with accounting principles generally accepted in the United States of America. The Audit Report is provided as Attachment 1.
