D. INVITATION TO BARGAINING UNIT PRESIDENTS/DESIGNEES AND/OR MEMBERS OF THE PUBLIC TO ADDRESS THE BOARD (GC54954.3)

- 1. Ms. Donna Hillman submitted a speaker card and addressed the Board on the matter of EDUHSD's policy on tardiness.
- 2. Ms. Teri Lillywhite, Vice President of CSEA Chapter 267, shared that classified members met earlier today and voted on their openers for negotiations for the school year. Recommendations will go to the Board at the September 25th Board Meeting.
- 3. Ms. Stephanie Davis, Co-President of the Faculty Association, thanked the administration for a great start to the school year. This year, they will be re-structuring the association and are in the process of re-writing board bylaws.

E. SUPERINTENDENT'S COMMENTS

1. Solar Energy Proposals.

Superintendent Carruth shared that we have made progress with the solar energy proposals. We have received 7 solar proposals for the District's consideration. Screening Committee Members include Mr. Del Rio, Mr. Brown, Mr. Whittenberg, Mr. Augino, and Superintendent Carruth. The Committee has met twice and has reviewed all proposals. They have invited 3 firms to interview with the Committee on September 12th. The committee will narrow the selections to 2 top firms to bring back to the Board at the September 25th Board Meeting.

2. Teacher Leadership Roles.

Superintendent Carruth stated that he and his team have been discussing Teacher Leadership Roles which are teacher level site support for the District's key initiatives to further the development of teacher talent. They will provide assistance in keeping initiatives "doable" and "manageable" for the site level teachers. Teacher Leadership Roles will make a difference at each one of our schools to further support students. He and his team will be putting together some proposals for the Board in order to efficiently be able to support these initiatives.

3. School Safety Update.

Superintendent Carruth shared that the District Action Task Force on School Safety met on September 5th and discussed what we have been able to move forward with on safety initiatives. We have secured two full-time School Resource Officers for additional support, purchased safety materials for each classroom and four additional AED's in each comprehensive cafeteria and will provide training to all Nutrition Services Supervisors. We will be participating in a District-wide Great California ShakeOut Drill (October 18th at 10:18 a.m.), lock down drills and active attacker training drills. Additionally, Youth Mental Health Training, school culture, as well as exploring emotional de-escalation training in the future.

4. <u>Serrano Mello-Roos Update.</u>

Superintendent Carruth stated that the El Dorado Union High School District is in comprehensive discussions to find a fair and reasonable approach to negotiate an end date to the Serrano Mello-Roos. We will both find a resolution that will protect the interest of the homeowners as well as the interest of future students.

G. BUSINESS SERVICES – ACTION/DISCUSSION ITEMS

1. Summer Technology Projects.

Assistant Superintendent Whittenberg introduced Mr. Jason King who presented the technology projects that were completed over the summer, including Windows 10 and Office 2016 upgrades; interactive TVs; upgraded servers' operating systems; the network bandwidth was upgraded to 10GB; the CORE switching equipment was upgraded to improve safety, speed and reliability; Phase 1: ORHS and part of the District Office; Phase 2: All remaining sites. Mr. King's team is finalizing a switch gear upgrade which should be completed shortly. The Board thanked Mr. King and his team for all of their dedication and hard work to get these projects finalized.

2. <u>Approval and Certification of the 2017-18 Unaudited Financial Report and Update to the 2018-19 Adopted Budget.</u>

Assistant Superintendent Whittenberg reported that the financial records for fiscal year 2017-18 have been reviewed and closed for the year. Year ending balances have been calculated and are being brought forward to 2018-19. The 2017-18 Unaudited Actuals include changes that have been identified since the Board of Trustees approved the adopted budget on June 19, 2018. Mr. Whittenberg advised that the District's auditors will conduct a thorough analysis of these numbers and report back on the audited actuals in January.

He advised that the District completed the year with a decrease in our General Fund balance. This decrease was \$2,887,980 less that the \$3,909,336 projected as "estimated actual" as part of the adopted budget for FY 2018-19. Mr. Whittenberg noted that the District does not follow a "use it or lose it" philosophy regarding budgeted funds. This encourages prudent planning and spending because all unspent funds are carried forward each year at each school site.

The 2017-18 Unaudited Actuals reflect an unassigned fund balance of \$4,362,525. The 2018-19 Budget reflects an unassigned fund balance of \$5,485,152. These figures include a 3% reserve for economic uncertainties.

Mr. Del Rio moved to approve and certify the 2017-18 Unaudited Actuals and the Update to the 2018-19 Adopted Budget. Mr. Brown seconded. Motion carried (4-0).

3. E-Rate Category 2 Purchase of Remaining Core Networking Equipment, Phase 2.

Assistant Superintendent Whittenberg shared that the equipment in the proposed project replaces 10+ year old core networking equipment which connects schools to the District. It also ties all school secondary data cabinets (IDFs) to the central school data cabinet (MDF). He stated that having updated equipment is vital to keeping school communications and internet traffic flowing. Internet access, email, phones, and paging via the school-wide PA systems rely on networking equipment. This project will be financed by Prop 51 reimbursements and eRate funds. Prop 51 reimbursements have been received and the approved eRate funding commitment letter was received on August 24, 2018 for the entire project (Phase 1 and Phase 2).

Upgrading part of the District Office and Oak Ridge High School's networking infrastructure was completed in Phase 1 and was approved by the Board on May 8, 2018 and completed by July 18, 2018. Phase 2 of the project will replace core networking equipment at El Dorado High School, El Dorado High School East, Independence High School, Ponderosa High School, Union Mine High School, the Virtual Academy, District Warehouse and the District Office. The project will ensure sufficient bandwidth exists to meet the educational and operational demands district-wide for the 2018-19 school year.

Mr. Brown moved to approve the E-Rate Category 2 Purchase of Remaining Core Networking Equipment, Phase 2. Mr. Del Rio seconded. Motion carried (4-0).
