G. EDUCATIONAL SERVICES - ACTION/DISCUSSION ITEMS

California Dashboard Local Indicators.
 The State Board of Education (SBE) ann

The State Board of Education (SBE) approved standards for the local indicators that support local educational agencies (LEAs) in measuring and reporting their progress within the appropriate priority area. For each local indicator, the performance standards are as follows:

- 1. Annually measure its progress in meeting the requirements of the specific LCFF priority; and
- 2. Report the results as part of a non-consent item at a regularly scheduled public meeting of the local governing board/body in conjunction with the adoption of the LCAP; and
- 3. Report results to the public through the Dashboard utilizing the SBE-adopted self-reflection tools for each local indicator.

The Administration recommends that the Board of Trustee receive the annual California Dashboard Local Indicator report that is supported by the District's adopted LCAP.

2. California Cadet Corp.

The Administration recommends the Board of Trustees authorize the Superintendent to sign a cooperative agreement to form a California Cadet Corp Unit at Union Mine High School (UMHS) with the understanding that UMHS shall no longer attempt to offer an Air Force JROTC program due to the Air Force being unable to provide UMHS with instructors.

The District's Energy Specialist, Anthony Williams and Cenergistic's Client Manager, Robert Etchamendy will present information on the great success of the energy program and key objectives which include cost savings via reduced utility spending, optimizing buildings and comfort systems, as well as the culture of sustainability created within the District.

2. ESSER III Funding.

The Elementary and Secondary School Emergency Relief (ESSER III) Fund is part of the COVID-19 federal funding for LEAs. This portion of the American Rescue Plan Act is designed to provide LEAs with emergency relief funds to address the impact COVID-19 has had, and continues to have, on elementary and secondary schools across the nation. Part of the ESSER III plan requires that districts collaborate with stakeholders on how the funds should be utilized. As a result, the District worked with both the Standards and Instructional Leadership Team and the Budget Advisory Committee to help generate suggestions and feedback. After hearing a brief presentation regarding the District's recommended use of the funds, the Board will be asked to open a public hearing and then to consider approving the recommendation.

The Administration recommends that the Board of Trustees approve the ESSER III Expenditure Plan.
