- 1. Mrs. Stephanie Davis, President of the Faculty Association, thanked the District for the collaborative negotiations meetings and the agreed upon Memorandum of Understanding. Teachers appreciate the support.
- 2. Ms. Teri Lillywhite, Vice President of CSEA, shared that their next negotiations meeting is on August 6, 2020 and she looks forward to conversations with Administration on how classified staff are going to return to work safely.

D. SUPERINTENDENT'S – ACTION/DISCUSSION ITEMS

1. Approval of the 2020-21 District's Re-Entry Plan.

Superintendent Carruth stated that he wanted to personally highlight the working relationship that our District has had and the support received from the County regarding opening schools. The County is working incredibly hard to be able to build its capacity to test and be able to ensure that at the right time schools can open, hopefully sooner rather than later. He commented that he has received and forwarded to the Board of Trustees a significant amount of correspondence from community members. He wants to assure families that the District is taking this responsibility with great seriousness and are doing everything to support our students.

State and Federal documents recognize that elementary school students have to come first. Early grade students have to get back in school where their learning losses are profound if they are not provided by direct instruction and their parents need to go back to work. If the County ends up on the Watch List, we know we are in distance learning, but in the same way high schools are viewed differently across the State and the Nation. Specifically, we look at issues where if we were to open school and make the Watch List, we know that high schools have to close. Elementary schools have the ability to do a local waiver to stay open because their services are imperative. We have also seen across the international community that high schools have a higher transmittal rate than elementary schools.

Superintendent Carruth reported that the El Dorado County Public Health has notified the District that the State of California has not provided the County sufficient COVID-19 resources to safely open in-person instruction for all students in the County by August 10, 2020. With priority testing capacity given to elementary students and schools consistent with State and Federal Guidelines. The County is aggressively increasing testing resources as he has mentioned before.

Mrs. Rodgers moved to approve the District Re-Entry Plan for in-person instruction starting on August 10, 2020 for some student groups, but will be starting all schools in the District in the distance learning model for the first quarter only or sooner if conditions allow. Provided the County is not on the State Watch List, the District intends to return to in-person instruction on October 5, 2020 or sooner as conditions allow, consistent with guidance from the State and Federal Guidelines and existing safety conditions. The Board hereby delegates to the Superintendent the authority to re-open schools to in-person learning under the conditions set forth in this motion. Mr. Del Rio seconded. The motion unanimously carried (5-0).

Mrs. Veerkamp commented that as a Board, they have received numerous emails and phone calls from concerned parents regarding distance learning and she sympathizes with everyone. She does not advocate for distance learning, but that is the consensus of the Board tonight. She is frustrated with the lack of leadership in Sacramento as they are trying to make the County comply with guidelines, but have not given time to prepare or the testing capability. She is hoping that we can get our students back in the classroom sooner rather than later.

Mr. Brown thanked County partners, Administration, and the Board of Trustees for their work. He has received many phone calls, emails, and letters from community members. It is a difficult decision because the most important thing is getting some normalcy back for our students so they can receive the education that they deserve.
