#### B. SUPERINTENDENT OPENING UPDATES

Superintendent Carruth greeted members of the Board, community in the audience and recognized Student Board Member, Alexis MacKie, who is attending the meeting by Zoom.

He wished all employees, students, and our community very happy holidays, Merry Christmas and a Happy New Year. He is very thankful for our employees who serve students every day. Our teachers, counselors, classified staff, and administrators are all doing amazing work in difficult times.

He reported that in November, the Superintendents from El Dorado County schools in coordination with the El Dorado County Superintendent of Schools, Dr. Ed Manansala, sent a letter to Governor Newsom expressing, among other things, the necessity of preserving the religious, personal belief and medical exemptions for students and staff regarding the COVID-19 vaccine and requesting criteria for when required student masking can become voluntary. He reported that since their meeting, fifteen other counties across the State have taken similar positions along with dozens of districts from each region of the State. The governor's staff acknowledged receipt of the letter. Superintendent Carruth shared a quote from Governor Newsom where he remarked that the State needs to refine all of this, we want to keep kids in schools and that his proposal includes personal exemptions so there is plenty of latitude for families to make decisions. Tonight the Board will consider a resolution strongly advocating against the COVID-19 vaccine requirement for students and staff. He concluded by wishing everyone happy holidays.

#### I. BUSINESS SERVICES - ACTION/DISCUSSION ITEMS

1. Approval of First District Certification of Interim Report for Fiscal Year 2021/2022 (SACS Form).

Assistant Superintendent, Robert Whittenberg reported the Board is required by Education Code Section 42131 to certify the District's financial condition to the County Office of Education and State Department of Education. There are three possible certifications:

- a. Positive: We will meet our fiscal obligation this year and the next two fiscal years.
- b. Qualified: We may not meet our fiscal obligation. OR
- c. Negative: We will not meet our fiscal obligation.

Another purpose of the Interim Report is for District Administration to review and to make revisions to the District's budget based upon updated income and appropriation information and changes to the final budget. El Dorado Union High School District submits interim reports to the Board of Trustees two times per year: first in December, using October data; second in March, using January data. The First Interim Financial Report projects that the District will have a positive fund balance, which meets State standards for a District our size, at year-end June 30, 2022.

Assistant Superintendent Robert Whittenberg presented the First Interim Financial Report. He advised that a thorough analysis of the District's budget was completed in support of the preparation of this report.

# 2. Approve Valcom PA, Clock and Bell System Installation

Assistant Superintendent Robert Whittenberg reported on June 8, 2021 the EDUHSD Board of Trustees passed Resolution 2020/21-13 approving the Valcom PA, Clock and Bell System as the District Standard after receiving the recommendation from a District-wide panel of administrators who attended a presentation of the Valcom System. The Valcom System was presented by Sierra Building Systems (SBS) based in Roseville, California and was unanimously chosen by our staff as the system that would best serve the District. The priorities set were:

- 1. Bell scheduling, consistent and easy to add and adjust bell schedules quickly
- 2. Interior Emergency Communication and audible public address system
- 3. Consistent and reliable clock operation
- 4. Audible exterior speakers evaluation and upgrades

The Valcom System is a digital clock system that displays the time on a 20" by 5" marquee VL520 (attachment A) that can also scroll messages in the event of a lockdown without having to announce the instructions over the PA System. The display also has a built-in speaker and microphone for instant return communication that can be finely tuned for each area. All that is required to operate the VL520 display unit is an existing data drop that can be shared with existing IT equipment, which in turn reduces the cost of installation and the need for additional data drops and IT switches.

The Valcom PA, Clock and Bell System will be procured through the California Multiple Award Schedule (CMAS) Contract Number 3-21-09-1007, 4-21-09-1006, and 4-21-09-1005. School Districts can participate in the CMAS program for the purchase of material, equipment and supplies provided that the purchases are the same as those made by the CA Dept. of General Services (DGS) and are under the same terms and conditions and specifications at a price lower than the District can obtain through their normal purchasing procedure. Education Code Section 17595 and Public Contract Code (PCC) Section 20653 authorizes school district's to purchase materials, equipment and supplies through the DGS and PCC Section 10298 specifically authorizes state and local agencies to contract with suppliers who are awarded CMAS contracts without further competitive bidding. The breakdown for all labor and materials are listed in Attachment B.

Mr. Dan Augino, Director, Maintenance, Operations and Facilities reviewed the system specifications and stated his recommendation for the Valcom PA Clock and Bell System with Sierra Building Systems.

Mr. Cary moved to approve the purchase and installation of a turn-key Valcom PA, Clock and Bell System with Sierra Building Systems for the sum total of \$724,325.00 listed in the attached Proposal. Mrs. Veerkamp seconded. The motion unanimously carried (5-0).

Assistant Superintendent Tony DeVille reported AB1200 and Government Code section 3547.5 required local education agencies to publicly disclose the provisions of all collective bargaining agreement before the Board gives final approval to the Agreement. The Disclosure Statement was included in the Agenda and was posted on the District bulletin board for public review.

The Board of Trustees and the District Administration have been engaged in contract negations with the Faculty Association and on Monday, November 29, 2021, signed a Tentative Agreement. Subsequently, the Faculty Association Board notified the District that the membership approved the Tentative Agreement, and it is now being presented for final approval to the Board of Trustees.

Mr. Cary commented (for the record) that he appreciated the professionalism of the Faculty Association during negotiations and working together during tough times. He noted there had been a comment made during public comments about "anti-union activity by the Board." He stated that the Board is quite well aware of the multiple Federal and State laws prohibiting such actions and abides by them.
