C. SUPERINTENDENT'S – INFORMATIONAL UPDATE

1. COVID-19 Update and Resolution Background.

Superintendent Carruth reported that the California Department of Public Health recently specified that people are required to wear masks in the classroom. The Board of Trustees has before them a Resolution declaring the need for local control on masking, the need for guidance on how the State expects the District to enforce the masking requirement and the need for the California Department of Public Health to align with the CVC's guidance. At the same time, it recognizes that we are required to comply with the California Department of Public Health to the extent that we can understand the guidance and successfully implement it. The District is also working closely with legal guidance from a liability perspective, as there is also a need to ensure the District is not financially jeopardized in the mist of this debate. There are a few critical legal questions yet to be answered before the District can make a final decision on how to approach face coverings. The District is in communication with a significant number of similar school districts from more rural and conservative areas of the State that have similar concerns as our community. The Board takes this situation very seriously. They have read every piece of correspondence sent to them and are studying the issue from every perspective, including the legal implications. That said, the Resolution tonight is a clear declaration of the District's intent and through the Board to notify the entities in California who are tasked with the guidance on our local position. More information is needed before a final statement on masks will be released, likely later this week. Superintendent Carruth read the Resolution that the Board will be considering tonight.

D. INVITATION TO BARGAINING UNIT PRESIDENTS/DESIGNEES AND/OR MEMBERS OF THE PUBLIC TO ADDRESS THE BOARD (GC54954.3)

1. Mrs. Stephanie Davis, Faculty Association President, shared that she sent the Resolution to all teachers for their feedback and commented that most are concerned

about how they are to track who is vaccinated and who is not. As the CDC says, the most important way to protect everyone is through the vaccination. Our County is on the low side in terms of numbers of vaccinations at 47.7%. She appreciates the District's desire for local control, but stated that it is difficult to assess what that policy would be if we got local control. Another year of quarantines and gaps in learning would be a disaster. If the District wants to pursue an optional mask policy, we also need to encourage vaccinations and tracking that data until we get to a point where masks are not needed. As of now with our case rate at 10.3% and the positivity rate at 5.5% it seems prudent to follow the State guidelines. Most teachers would like to make masks optional as nobody enjoys wearing them, but teachers with unvaccinated children at home and immunocompromised people who the vaccine has not been an effective deterrent for must still be protected. Reasonable caution seems the wisest approach for now. They want students back in school full time without unnecessary quarantines so some reasonable precautionary measures seem necessary. Teachers are concerned about the safety of students and staff.

Mr. Cary moved to approve Resolution #2021/22-01 Declaring Need for Local Control in Masking and Demand for Guidance on Enforcement and Need to Align School Guidance with the United States Centers for Disease Control and Prevention, and Authorizing Necessary Actions in Connection Therewith including an additional bullet point to read "Declare that the academic and emotional needs of students are paramount and lost in the guidance the CDPH provided for schools." Mrs. Rodgers seconded. Motion carried (5-0).
