The El Dorado Union High School District meaningfully consulted in the use of the ESSER III funds by ensuring that the expenditures were aligned with the need to safely reopen schools and implement the District’s existing Local Control and Accountability Plan (LCAP). Leadership from both bargaining units were provided with background information on the use of funds, and their feedback sought. Site principals and administrators participated in feedback sessions. Two district-wide committees, the Standards and Instructional Leadership Team (SILT) and the Budget Advisory Committee, provided recommendations. Parents were surveyed as part of the LCAP development process, and SILT parent representatives provided recommendations. The California Healthy Kids Survey results were utilized to better understand the needs of students.

Community members wanted funds to go to the required expenditures necessary to safely reopen schools. Additional custodial staff and contract tracing health personnel were deemed essential to meeting safe school reopening expectations. In addition, the disruption caused by 2020 and 2021 school closures and hybrid schedules, had a profound impact on students with disabilities. Additional special education staff and mental health services for students with disabilities was determined to be essential to addressing learning loss for the District's most vulnerable students. The mandate to provide distance learning for the 2021-22 school year is a one-time requirement and ESSER III funds were identified as a means to pay for the program.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.
